- Make sure that we access the summative assessment and we are looking at all the essentials that we taught during that unit
- If you choose to do a summative and not test over the whole unit, consider do we need the rest of the lessons and do they need to know them for the next grade level; Also think about if we continue to go through this, is there something that we will not get to that is fundamental for them in the next grade level
- Pull up assessments ahead of time and tell kids a little bit of information so they will have clarity as to what they are supposed to be doing on the assessment- Decide as a team if this is something that you want to do (you can also write on the assessment to give them certain vocabulary words to help)
- Got to have it checklist(check off pieces as you go through lesson)in teacher reference section and rubric to go with assessments
- Take the same rubric for the practices (in open-scied and cognia) and make it task specific for whatever unit you are in
